5. HANDS CLEAN & PROPERLY WASHED; GLOVES USED PROPERLY ⚠️ **CRITICAL** ⚠️

Inspector Comments: Observed no soap at the handwashing sink dispenser in the kitchen. Employee stated they had no handwashing soap, and use dishwashing detergent until handwashing soap is obtained. Directed employee to immediately obtain a pump-style handwashing soap dispenser. All employees were directed to wash their hands properly before continuing with food preparation.

Violation Description: Employees hands and exposed arms shall be kept clean, with fingernails properly trimmed. Employees are required to properly wash their hands: before handling food, equipment, or utensils; as often as necessary during food preparation, to remove soil and contamination; when switching from working with raw to ready-to-eat food; before putting on gloves and working with food; after touching body parts; after using toilet room; or any time when contamination may occur. Employees shall minimize bare hand and arm contact with non-prepackaged food that is in ready-to-eat form. Whenever gloves are worn, they shall be changed or replaced as often as handwashing is required. Approved hand sanitizer can be used in addition to proper handwashing. 6. ADEQUATE HANDWASHING FACILITIES SUPPLIED & ACCESSIBLE

Inspector Comments: Observed:
- wall mounted paper towel dispenser at the kitchen handwashing sink to be in disrepair. Provide cover plate to the towel dispenser and ensure dispenser is in good working order.
- no soap at the wall mounted soap dispenser at the kitchen handwashing sink. Employee provided a pump-style soap dispenser during the inspection. Ensure all handwashink sink soap dispensers are fully supplied and in good working order.
- large soap buckets and food equipment stored directly in front of the kitchen handwashing sink. Discontinuing storing items directly in front of the hand washing sink.
- a metal scrub brush stored directly in the compartment of the kitchen handwashing sink. Do not store any items in the handwashing sink. Handwashing sink is to only be used for handwashing.

Violation Description: Adequate facilities exclusively for handwashing shall be provided in food preparation areas and within toilet rooms. Handwashing soap, and towels or drying device, shall be provided in dispensers. Handwashing facilities shall be clean, unobstructed, and accessible at all times for employee use. (113953, 113953.1, 113953.2, 114067(f), 114143 (e))

9. PROPER COOLING METHODS

POINTS

Inspector Comments: Observed a large covered pot of cooked rice, measuring 176F, left unattended on the food preparation sink drain board. All potentially hazardous food shall be RAPIDLY cooled from 135°F to 70°F, within 2 hours, and then from 70°F to 41°F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath, stirring frequently; using rapid cooling equipment; or using containers that facilitate heat transfer.

Violation Description: All potentially hazardous food shall be rapidly cooled from 135°F to 70°F within 2 hours, and then from 70°F to 41°F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath, stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. (114002, 114002.1)

13. FOOD: UNADULTERATED, NO SPOILAGE, NO CONTAMINATION

Inspector Comments: Observed:
- a package of sugar to be damaged due to previous water leak in the ceiling above. Operator discarded package of sugar during the inspection.
- several cans of expired food items on the customer shelves. Discard all expired food items from the shelves.

Violation Description: All food shall be manufactured, produced, prepared, compounded, packed, stored, transported, kept for sale, and served to be pure and free from adulteration, spoilage, and contamination. Food shall be fully fit for human consumption. (113967, 113976, 113980, 113982, 113988, 113990, 114035, 114254.3)

28. FOOD SEPARATED AND PROTECTED FROM CONTAMINATION

Inspector Comments: Observed:
- bowls/non-handled containers used as food scoops in the walk in cooler and kitchen. Only use handled food scoops, and ensure the handle does not come into direct contact with the food.
- large uncovered food containers on the storage racks in the walk in cooler. Unless in the cooling process, all food containers are to be covered in an approved manner.
- an uncovered container of raw beef stored directly above covered foods and uncovered vegetables in the two door preparation cooler. Store all raw animal products beneath cooked foods, produce and ready to eat food items in refrigerators to prevent contamination.

Violation Description: All food shall be separated and protected from contamination. (113984, 113986, 114060, 114067(a, d, e), 114069(a, d), 114073, 114077, 114089.1(c), 114143(c))

30. TOXIC SUBSTANCES PROPERLY IDENTIFIED, STORED, USED

POINTS

Inspector Comments: Observed:
- an unlabeled chemical spray bottle stored directly in front of the kitchen handwashing sink. Label all chemical spray bottles.
- an unmarked pump sprayer on the floor directly next to the ice machine in the hallway storage room. Relocate pump sprayer. Facility is to only use approved pest control services to eliminate insect/vermin activity.

Violation Description: All poisonous substances, detergents, bleaches, and cleaning compounds shall be stored in an approved manner which prevents contamination of food or food-contact surfaces. All poisonous or toxic substances shall be properly labeled. (114254, 114254.1, 114254.2)

34. UTENSILS AND EQUIPMENT APPROVED, GOOD REPAIR

Inspector Comments: Observed:
- a leak beneath the ice machine in the hallway storage room. Repair leak beneath the ice machine in an approved manner.
- ice accumulation on fan box in the walk in cooler. Eliminate ice accumulation and ensure walk in cooler is in good working order.

Violation Description: All utensils and equipment shall be approved and in good repair. (114130, 114130.1-114130.6, 114132, 114133, 114137, 114175, 114177, 114257)

37. EQUIPMENT, UTENSILS, LINENS: STORAGE AND USE

POINTS

Inspector Comments: Observed:
- chest style freezers stored directly on the floor in the back storage room. Elevate chest freezers at least 6 inches above the floor in an approved manner (eg. metal legs or casters).
- food utensils wedged in between the three compartment sink and FRP wall surfaces. Discontinue storing utensils in the crack between the three compartment sink and FRP wall surfaces.

Violation Description: Utensils and equipment shall be handled and stored in an approved manner, protected from contamination. All clean and soiled linen shall be properly stored. (114067(h), 114074, 114081, 114083, 114119, 114121, 114143(a-b), 114161, 114172, 114178, 114179, 114185, 114185.2, 114185.3, 114185.4, 114185.5)

40. WIPING CLOTHS: PROPERLY USED AND STORED

POINTS

Inspector Comments: Observed:
- 0 ppm chlorine in the sanitizer bucket in the kitchen. Directed employee to add a sufficient amount of chlorine to the bucket.
- a wiping cloth stored beneath a cutting board on a preparation table in the kitchen. Discontinue using wiping cloths as cutting board liners.

Violation Description: Wiping cloths used to clean food spills shall be used only once, unless stored in an approved concentration of sanitizer solution and laundered daily. (114135, 114185.1, 114185.3(d-e))

43. TOILET FACILITIES: PROPERLY CONSTRUCTED, SUPPLIED, CLEANED

Inspector Comments: Observed restroom entrance door to be propped open. Maintain restroom door closed and ensure self-closing mechanism is attached and in good working order.

Violation Description: Toilet facilities shall be maintained clean, sanitary, and in good repair. Toilet rooms shall be separated by a well-fitting self-closing door. Toilet tissue shall be provided in a permanently installed dispenser at each toilet. Toilet facilities shall be provided for patrons in establishments with more than 20,000 sq. ft. and in establishments offering on-site consumption. (114250, 114250.1, 114276)

44. PREMISES; PERSONAL ITEM STORAGE AND CLEANING ITEM STORAGE

POINTS

Inspector Comments: Observed the accumulation old/un-used food equipment and non-food equipment (including swamp cooler and coolers) in the hallway storage room and back storage room. Remove all items that are not necessary for the operation of the food facility.

Violation Description: Lockers or another approved area for personal belongings shall be provided. The premises of each food facility shall be kept clean and free of litter and items that are unnecessary to the operation or maintenance of the facility. At least one janitorial sink with hot and cold running water shall be provided. Cleaning supplies and equipment shall be stored separate from food and food-related areas. Mops shall be stored in such a way that allows air-drying. (114123, 114256, 114256.1, 114256.2, 114256.4, 114257.1, 114279, 114281, 114282)

45. FLOORS, WALLS, CEILING: GOOD REPAIR / FULLY ENCLOSED

POINTS

1

Inspector Comments: Observed:

- missing/damaged ceiling tiles in the customer area of the store due to previous water leak. Replace all affected ceiling surfaces in an approved manner. Areas where there is open foods and food preparation/handling must have non-perforated ceiling tiles that are smooth and easily cleanable.
- areas of the back storage room not fully enclosed (where fan/vents are located and in wall surfaces). Back room must be fully enclosed to prevent debris/vermin entry points. This room is not approved for open food storage.

Violation Description: The floors, walls, ceilings finishes must be of an approved material, durable, smooth, nonabsorbent, and easily cleanable. Food facilities shall be fully enclosed. (114143 (d), 114257, 114266, 114268, 114271, 114272)

46. FLOORS, WALLS, AND CEILINGS: CLEAN

POINTS

1

Inspector Comments: Observed:

- water accumulation on the floors in the hallway storage room.
 - debris accumulation beneath storage equipment in the back storage room.
- Thoroughly clean all affected floor surfaces.

Violation Description: Floors, walls, and ceilings shall be maintained clean. (114257, 114268.1)

49. FOOD HANDLER CERTIFICATIONS AVAILABLE, CURRENT, COMPLETE

Inspector Comments: Observed the two cooks in the kitchen to not have their food handler cards. Provide approved Riverside County food handler cards for all employees. Food handler card exam can be taken online at www.riverside.statefoodsafety.com or at our environmental health offices.

Violation Description: County of Riverside Environmental Health Food Handler Certification(s) are available and current for all employees who prepare, store, or serve exposed food. (Riverside County Ordinance 567)

REASONS FOR IMMEDIATE CLOSURE OF A FOOD FACILITY

Per California Health and Safety Code Section 114409 (a):
 "If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility immediately closed."

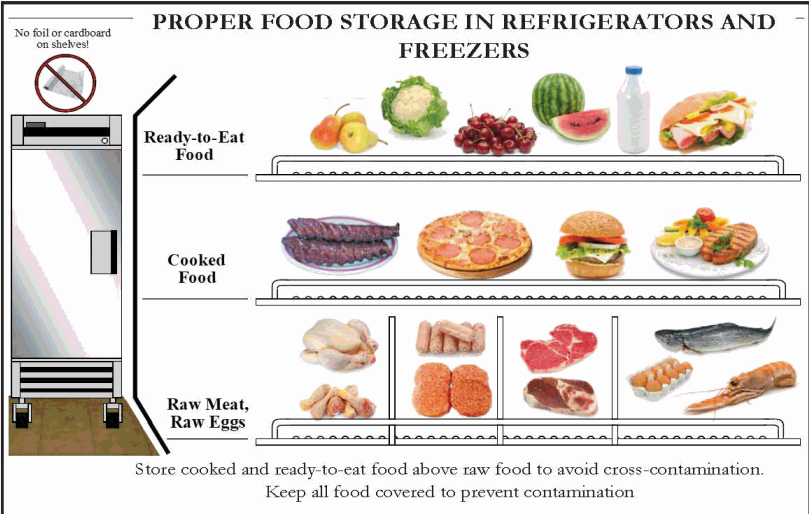
A food facility may be closed for any of the following reasons:

- Overflowing sewage (inside or outside the facility)
- No potable water
- No hot water
- No electricity
- Rodent or insect infestation
- Any other conditions at the facility that may create an imminent public health risk

In addition to the reasons above, Per California Health and Safety Code Section 114411:

"The enforcement agency may, after providing opportunity for a hearing, modify, suspend, or revoke a permit for serious or repeated violations of any requirement of this part or for interference in the performance of the duty of the enforcement officer."

PROPER FOOD STORAGE IN REFRIGERATORS AND FREEZERS



No foil or cardboard on shelves!

Ready-to-Eat Food

Cooked Food

Raw Meat, Raw Eggs

Store cooked and ready-to-eat food above raw food to avoid cross-contamination. Keep all food covered to prevent contamination.

MANUAL SANITIZING OF EQUIPMENT AND UTENSILS USING A THREE COMPARTMENT SINK

1. **SCRAPE**, clean, or soak items as necessary before washing.
2. **WASH** items in detergent and hot water of at least 100°F in the first sink.
3. **RINSE** items in clear water in the second sink.
4. **SANITIZE** by submerging each item in a sanitizing solution in the third sink. Use one of the following sanitizing methods:
 - 100ppm of a chlorine based sanitizer for a minimum of 30 seconds in the solution
 - 200ppm of a quaternary ammonium based sanitizer for a minimum of 60 seconds in the solution
 - 25ppm of an iodine based sanitizer for a minimum of 60 seconds in the solution
 - Water at a temperature of 171°F for a minimum of 30 seconds in solution
5. **AIR DRY** all items on the drain board.



PROPER COOLING OF FOOD IN YOUR FACILITY

Potentially hazardous foods should always be rapidly cooled.

TIME IS THE KEY FACTOR IN PROPER COOLING

- Foods must cool from 135°F to 70°F in 2 hours or less
- Foods must cool from 70°F to 41°F in 4 hours or less

Use one of the following methods to cool food properly:

- Break large foods down into smaller portions and place in shallow pans no more than 4 inches deep. Metal pans cool better than glass or plastic pans.
- Add ice as an ingredient to replace water used in the recipe.
- Place foods within an ice bath and frequently stir the foods to speed the cooling process.
- Loosely cover foods so that heat and steam can escape during cooling.
- Arrange containers within a refrigeration unit so that air can flow properly around containers.
- Use special equipment like chill paddles or blast chillers to rapidly bring down food temperature.









Use an accurate thermometer to verify the food is being cooled within proper timeframes.

PROPER FOOD THAWING METHODS

1. Under refrigeration
2. In a microwave oven on "defrost"
3. Submerged under cold running water in an approved preparation sink for no longer than 2 hours
4. As part of the cooking process

INTERNAL COOKING TEMPERATURES

Use a probe thermometer to take internal cooking temperatures
