#### 7. PROPER HOT & COLD HOLDING TEMPERATURES

**POINTS** 

Inspector Comments: Measured the following food inside walk-in cooler holding at 45F:

- 1) 12 packages of chorizo
- 2) several packaged of shredded cheese
- 3) 11 packaged of hot dogs
- 4) 7 packages of raw bacon
- 5) Several gallons of milk
- 6) Several bottles of milk.

Walk-in cooler measured at 38F in all other locations. The food items were located in a corner blocked by two other stands with cardboard not allowing airflow to properly hold potentially hazardous food at proper holding temperature. All milk and cheese products were relocated to another shelf inside walk-in cooler at this time. All other food items were voluntarily discarded at this time. Ensure all potentially hazardous food is maintained at proper holding temperature.

**Violation Description:** Potentially hazardous food shall be held at or below 41°F / 45°F or at or above 135°F. Potentially hazardous food removed from proper holding temperature during preparation must be returned to proper temperature within 2 hours. Potentially hazardous food shall be received at proper temperature without evidence of temperature abuse. (113996, 113998, 114037)

#### 13. FOOD: UNADULTERATED, NO SPOILAGE, NO CONTAMINATION

**POINTS**

**Inspector Comments:** Observed gnawed package of sunflower seeds below counter for soda dispenser. Person in charge discarded sunflower seeds at this time. If any gnawed food products are found person in charge instructed to discard items.

**Violation Description:** All food shall be manufactured, produced, prepared, compounded, packed, stored, transported, kept for sale, and served to be pure and free from adulteration, spoilage, and contamination. Food shall be fully fit for human consumption. (113967, 113976, 113980, 113982, 113988, 113990, 114035, 114254.3)

#### 21. HOT AND COLD WATER AVAILABLE

**POINTS**

**Inspector Comments:** Measured maximum water temperature at 115F. Increase water temperature to a minimum of 120F by reinspection on 5/31/22.

**Violation Description:** An adequate, protected, pressurized, potable supply of hot water and cold water shall be provided at all times. Hot water of at least 120°F must be provided for facilities with unpackaged food or packaged potentially hazardous food. Handwashing facilities shall be equipped to provide warm water for at least 15 seconds. (113953(c), 114189, 114192 (a,d), 114192.1, 114195)

#### 23. NO RODENTS, INSECTS, BIRDS, OR ANIMALS

Inspector Comments: Observed several rodent dropping below counter below soda dispenser. Rodent droppings were found on food boxes and packaged cups and lids. Inspector did not observed rodent droppings in any other locations inside facility at this time. Properly treat facility and provide pest control invoice by 5/26/22. and email to Bwhitney@rivco.org. Properly exclude all entrance points inside facility to prevent rodent entry. Clean and sanitize affected area in an approved manner. Inspector impounded all open food facility is not permitted to sell soda from dispenser or repackage ice for sale until approved by a member of this Department. A reinspection has been set for 5/31/22 if vermin evidence is found further enforcement action will be taken ( hearing, closure citation, ect).

Violation Description: Each food facility shall be kept free of vermin. Only approved animals, such as service animals or decorative fish in aquariums, are permitted inside a food facility. (114259.1, 114259.4, 114259.5)

#### 25. PERSON IN CHARGE PRESENT AND PERFORM DUTIES; DEMONSTRATION OF KNOWLEDGE

**POINTS** 

**Inspector Comments:** Person in charge was unable to explain how facility washes their equipment and stated that someone else does it. Education given at this time. Ensure person in charge and all employees are knowledgeable about food safety.

**Violation Description:** A person in charge shall be present at the food facility during all hours of operation. The person in charge and all food employees shall have adequate knowledge and shall be trained in food safety as it relates to their assigned duties. The person in charge shall have adequate knowledge of major food allergens and must provide education to employees. (113945-113945.1, 113947, 113947.1(b)(2), 113984.1, 114075)

#### 30. TOXIC SUBSTANCES PROPERLY IDENTIFIED, STORED, USED

**POINTS** 

**Inspector Comments:** Observed unlabeled chemical spray bottle on shelf at register. Properly label all chemical spray bottles as to its contents.

Violation Description: All poisonous substances, detergents, bleaches, and cleaning compounds shall be stored in an approved manner which prevents contamination of food or food-contact surfaces. All poisonous or toxic substances shall be properly labeled. (114254, 114254.1, 114254.2)

#### 33. FOOD PROPERLY LABELED AND HONESTLY PRESENTED, MENU LABELING



Inspector Comments: Observed missing label for packaged ice. Provide a label that ice is packaged at this location including DBA (facility name) and facility address on ice freezer.

Violation Description: Any food is misbranded if its labeling is false or misleading, if it is offered for sale under the name of another food, or if it is an imitation of another food for which a definition and standard of identity has been established by regulation. All food menu items shall be properly identified and honestly presented. Food establishments with 20 or more locations, conducting similar business, must provide approved menu nutritional labeling information. Infant formula cannot be sold or offered for sale after the "use by" date printed on the package. (114087, 114089, 114089.1(a, b), 114090, 114093.1, 114094, 114094.5)

#### 35. WAREWASHING: INSTALLED, MAINTAINED. PROPER USE, TEST MATERIALS



Inspector Comments: Person in charge was not able to provide any test strips. Ensure facility has test strips to ensure approved sanitizer solution is being used.

Violation Description: Food facilities that prepare food shall have approved warewashing equipment. Testing equipment and materials shall be provided to measure the wash water temperature and applicable sanitization method. (114067(g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125)

#### 36. EQUIPMENT / UTENSILS PROPERLY INSTALLED, CLEAN; ADEQUATE CAPACITY

POINTS

Inspector Comments: Observed mildew on ice machine deflector shield. Properly clean and sanitize ice machine in an approved

Violation Description: All utensils and equipment shall be clean and installed in an approved manner. Equipment type and quantity shall be adequate for the operation.(114115, 114130.3, 114139, 114153, 114163, 114165, 114167, 114169, 114175, 114180, 114182, 114257)

#### 40. WIPING CLOTHS: PROPERLY USED AND STORED



Inspector Comments: Observed soiled wiping cloths store don food boxes in several location. Relocate all soiled wiping cloths in an approved designated area to be laundered.

Violation Description: Wiping cloths used to clean food spills shall be used only once, unless stored in an approved concentration of sanitizer solution and laundered daily. (114135, 114185.1, 114185.3(d-e))

#### 45. FLOORS, WALLS, CEILING: GOOD REPAIR / FULLY ENCLOSED



Inspector Comments: Observed the following:



1) Ceiling to be damaged in several locations (customer area and above employee restroom). Repair ceiling in an approved manner.

- 2) Hole in wall around pipe above 3-compartment sink. properly seal around pipe to prevent vermin entry.
- 3) Damaged flooring throughout facility. Repair/ replace floor so floor is smooth and easily cleanable.

Violation Description: The floors, walls, ceilings finishes must be of an approved material, durable, smooth, nonabsorbent, and easily cleanable. Food facilities shall be fully enclosed. (114143 (d), 114257, 114266, 114268, 114271, 114272)

#### **Overall Inspection Comments**

This facility is not approved to sell any open food due to possible rodents. No signature captured due to pandemic, inspection report emailed to Goldenlantern1@gmail.com

#### REASONS FOR IMMEDIATE CLOSURE OF A FOOD FACILITY

Per California Health and Safety Code Section 114409 (a):

"If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility immediately closed."

A food facility may be closed for any of the following reasons:

- · Overflowing sewage (inside or outside the facility)
- · No potable water
- · No hot water
- · No electricity
- · Rodent or insect infestation
- Any other conditions at the facility that may create an imminent public health risk

In addition to the reasons above, Per California Heath and Safety Code Section 114411:

"The enforcement agency may, after providing opportunity for a hearing, modify, suspend, or revoke a permit for serious or repeated violations of any requirement of this part or for interference in the performance of the duty of the enforcement officer."



Store cooked and ready-to-eat food above raw food to avoid cross-contamination.

Keep all food covered to prevent contamination

### MANUAL SANITIZING OF EQUIPMENT AND UTENSILS USING A THREE COMPARTMENT SINK

- 1. SCRAPE, clean, or soak items as necessary before washing.
- 2. WASH items in detergent and hot water of at least 100°F in the first sink.
- 3. RINSE items in clear water in the second sink
- 4. SANITIZE by submerging each item in a sanitizing solution in the third sink. Use one of the following sanitizing methods:
  - $\bullet$  100ppm of a chlorine based sanitizer for a minimum of 30 seconds in the solution
  - 200ppm of a quaternary ammonium based sanitizer for a minimum of 60 seconds in the solution
  - 25ppm of an iodine based sanitizer for a minimum of 60 seconds in the solution
  - Water at a temperature of 171°F for a minimum of 30 seconds in solution

5. AIR DRY all items on the drain board.



#### PROPER COOLING OF FOOD IN YOUR FACILITY

Potentially hazardous foods should always be rapodly cooled.

#### TIME IS THE KEY FACTOR IN PROPER COOLING

- Foods must cool from 135°F to 70°F in 2 hours or less
- Foods must cool from 70°F to 41°F in 4 hours or less

Use one of the following methods to cool food properly:

- Break large foods down into smaller portions and place in shallow pans no more than 4 inches deep. Metal pans cool better than glass or plastic pans.
- Add ice as an ingredient to replace water used in the recipe.
- Place foods within an ice bath and frequently stir the foods to speed the cooling process.
- · Loosely cover foods so that heat and steam can escape during cooling.
- Arrange containers within a refrigeration unit so that air can flow properly around containers.
- Use special equipment like chill paddles or blast chillers to rapidly bring down food temperature.

Use an accurate thermometer to verify the food is being cooled within proper timeframes

#### PROPER FOOD THAWING METHODS

- Under refrigeration
- In a microwave oven on "defrost"
  - Submerged under cold running water in an approved preparation sink for no longer than 2 hours
  - As part of the cooking process



#### INTERNAL COOKING TEMPERATURES

Use a probe thermometer to take internal cooking temperatures



Food temperature cannot be felt - use your probe thermometer!
