7. PROPER HOT & COLD HOLDING TEMPERATURES **⚠ CRITICAL ⚠**

Inspector Comments: Measured the following items inside cold top /cold drawer unit at cookline measuring 50F-60F:

- 1) Container of Sliced cheese
- 2) Several cooked ribs
- 3) several bags of cooked noodles
- 4) metal insert of marinara sauce
- 5) metal insert of butter lemon sauce
- 6) metal insert of cut cherry tomatoes
- 7) container of cooked asparagus
- 8) Several bags of cooked rice
- 9) Several bags of cooked onion
- 10) Several bags of cooked mashed potatoes
- 11) Several bags of cooked sweet potato

These items were inside unit for approximately 2.5 hours prior to temperature taken. Employee placed items into walk-in cooler for rapid cooling. Measured items at end of inspection at 30F.

Measured the following items inside cold top salad unit at 44F-50F:

- 1) Several plastic containers of ranch dressing
- 2) Metal insert of shredded parmesan cheese

These items were placed inside unit approximately 1 hour prior to temperature taken.

- 3) Two metal containers of sour cream
- 4) Two metal containers of whipped butter.

These items were placed inside unit the day prior to inspection and were voluntarily discarded at this time.

Measured the following items inside cold top unit adjacent to grill and fryers:

- 1) Sliced tomatoes at 54F
- 2) Thousand island dressing at 55F
- 3) Dressing made with mayonnaise at 53F

Measured the following soups inside hot holding unit adjacent to salad prep area:

- 1) Broccoli cheddar soup at 130F
- 2) Clam chowder at 129F
- 3) Vegetable beef soup at 129F

Employee stated items are reheated to 165F and placed in hot holding unit and items were placed inside 1 hour prior to temperature taken. Inspector instructed employee to reheat soup to 165F at this time. Measured soup at 173F inside hot holding unit.

Measured the following inside single door Beverage air cooler adjacent to warewash area at 40F-47F:

- 1) Cooked spicy mongolian beef BAO
- 2) BBQ pork BAO
- 3) Teriyaki chicken BAO
- 4) Cooked teriyaki chicken topping
- 5) Spicy kung pao chicken topping

Employee stated items were placed inside unit approximately 3 hours prior to temperature taken. Items were placed into walk-in cooler for rapid cooling. Measured items at 30F at end of inspection.

Ensure all potentially hazardous food is maintained at proper holding temperature at all times.

Violation Description: Potentially hazardous food shall be held at or below 41#F / 45#F or at or above 135#F. Potentially hazardous food removed from proper holding temperature during preparation must be returned to proper temperature within 2 hours. Potentially hazardous food shall be received at proper temperature without evidence of temperature abuse. (113996, 113998, 114037)

14. FOOD CONTACT SURFACES; CLEAN AND SANITIZED **⚠ CRITICAL ⚠**

Inspector Comments: Measured 10ppm Cl sanitizer solution on dishes coming out of dishwasher during active warewashing. Person in charge noticed sanitizer bucket was low and changed sanitizer bucket for a new one. Measured 50ppm Cl sanitizer solution on dish at this time. Ensure employees are checking sanitizer solution on dish surface frequently to ensure proper warewashing procedure is being conducted.

Violation Description: All food contact surfaces of utensils and equipment shall be properly cleaned and sanitized. Food contact surfaces shall be clean to the sight and touch, no accumulation of dust, dirt, food residue, and other debris. Inspector Comments: Person in charge was asked how to wash equipment in 3-compartment sink. Person in charge was unable to answer the minimum wash water temperature. Person in charge also stated dishes are submerged into quat sanitizer solution for 30 seconds. Education given at this time. Ensure employees and person in charge is knowledgeable about food safety as it relates to their job duties.

Violation Description: A person in charge shall be present at the food facility during all hours of operation. The person in charge and all food employees shall have adequate knowledge and shall be trained in food safety as it relates to their assigned duties. The person in charge shall have adequate knowledge of major food allergens and must provide education to employees. (113945-113945.1, 113947, 113947.1(b)(2), 113984.1, 114075)

28. FOOD SEPARATED AND PROTECTED FROM CONTAMINATION

Inspector Comments: Observed the following:

- 1) Food stored below first shelf in reach in freezer without lid or covering. Ensure all food stored below first shelf have a lid or covering to prevent any possible contamination.

- 2) New soda syrup boxes stored on shelf below mops and equipment in enclosed dumpster area. Discontinue storing food in this manner and store all food inside and protected from vermin or contamination.

- 3) Old beer kegs stored inside dumpster area. Discontinue storing equipment in dumpster area.

Violation Description: All food shall be separated and protected from contamination. (113984, 113986, 114060, 114067(a, d, e), 114069(a, d), 114073, 114077, 114089.1(c), 114143(c))

31. ADEQUATE FOOD STORAGE; FOOD STORAGE CONTAINERS IDENTIFIED

Inspector Comments: Observed bowl of caesar salad placed on top of inserts inside salad bar cold top unit. Properly store food in an approved manner to ensure proper holding temperature.

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving. (114047, 114049, 114051, 114053, 114055, 114067(h), 114069(b))

34. UTENSILS AND EQUIPMENT APPROVED, GOOD REPAIR

Inspector Comments: Observed the following:

- 1) Cold top unit/ cold drawer unit at cookline holding 50F-60F
 - 2) Cold top unit adjacent to grill and fryer at 40F-55F
 - 3) Salad bar cold top unit holding at 44F-50F
 - 4) Single door Beverage air reach-in cooler at 46F
- Equipment has been impounded and not approved for use until repaired and verified by a member of this department.

Observed severely worn cutting board at cookline cold top unit. Repair/ replace cutting board in an approved manner.

Violation Description: All utensils and equipment shall be approved and in good repair. (114130, 114130.1-114130.6, 114132, 114133, 114137, 114175, 114177, 114257)

36. EQUIPMENT / UTENSILS PROPERLY INSTALLED, CLEAN; ADEQUATE CAPACITY

Inspector Comments: Observed an accumulation of food debris and residue inside and on outside of microwaves throughout facility.

Observed an accumulation of food debris inside hot holding drawer containing cooked potatoes.

All equipment and utensils shall be kept clean and free of an accumulation of dust, dirt, food residue, and other debris.

Violation Description: All utensils and equipment shall be clean and installed in an approved manner. Equipment type and quantity shall be adequate for the operation. (114115, 114130.3, 114139, 114153, 114163, 114165, 114167, 114169, 114175, 114180, 114182, 114257)

Violation Description: Utensils and equipment shall be handled and stored in an approved manner, protected from contamination. All clean and soiled linen shall be properly stored. Inspector Comments: Measured a plate of food that was stored on top of microwave at 88F. Employee stated the plate of food was her breakfast from the morning. Store all personal items in lockers or other approved designated area.

Violation Description: Lockers or another approved area for personal belongings shall be provided. The premises of each food facility shall be kept clean and free of litter and items that are unnecessary to the operation or maintenance of the facility. At least one janitorial sink with hot and cold running water shall be provided. Cleaning supplies and equipment shall be stored separate from food and food-related areas. Mops shall be stored in such a way that allows air-drying. (114123, 114256, 114256.1, 114256.2, 114256.4, 114257.1, 114279, 114281, 114282)

REASONS FOR IMMEDIATE CLOSURE OF A FOOD FACILITY

Per California Health and Safety Code Section 114409 (a):
 "If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility immediately closed."

A food facility may be closed for any of the following reasons:

- Overflowing sewage (inside or outside the facility)
- No potable water
- No hot water
- No electricity
- Rodent or insect infestation
- Any other conditions at the facility that may create an imminent public health risk

In addition to the reasons above, Per California Health and Safety Code Section 114411:

"The enforcement agency may, after providing opportunity for a hearing, modify, suspend, or revoke a permit for serious or repeated violations of any requirement of this part or for interference in the performance of the duty of the enforcement officer."

PROPER FOOD STORAGE IN REFRIGERATORS AND FREEZERS

Ready-to-Eat Food

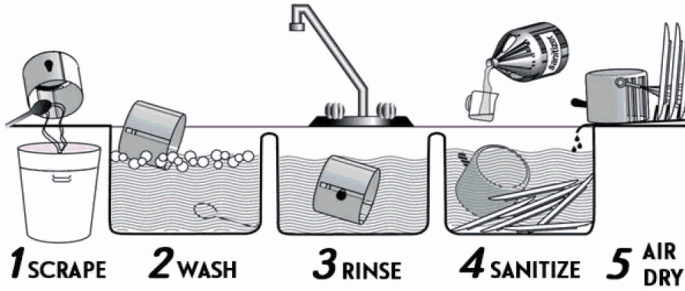
Cooked Food

Raw Meat, Raw Eggs

Store cooked and ready-to-eat food above raw food to avoid cross-contamination. Keep all food covered to prevent contamination.

MANUAL SANITIZING OF EQUIPMENT AND UTENSILS USING A THREE COMPARTMENT SINK

1. **SCRAPE**, clean, or soak items as necessary before washing.
2. **WASH** items in detergent and hot water of at least 100°F in the first sink.
3. **RINSE** items in clear water in the second sink.
4. **SANITIZE** by submerging each item in a sanitizing solution in the third sink. Use one of the following sanitizing methods:
 - 100ppm of a chlorine based sanitizer for a minimum of 30 seconds in the solution
 - 200ppm of a quaternary ammonium based sanitizer for a minimum of 60 seconds in the solution
 - 25ppm of an iodine based sanitizer for a minimum of 60 seconds in the solution
 - Water at a temperature of 171°F for a minimum of 30 seconds in solution
5. **AIR DRY** all items on the drain board.



PROPER COOLING OF FOOD IN YOUR FACILITY

Potentially hazardous foods should always be rapidly cooled.

TIME IS THE KEY FACTOR IN PROPER COOLING

- Foods must cool from 135°F to 70°F in 2 hours or less
- Foods must cool from 70°F to 41°F in 4 hours or less

Use one of the following methods to cool food properly:

- Break large foods down into smaller portions and place in shallow pans no more than 4 inches deep. Metal pans cool better than glass or plastic pans.
- Add ice as an ingredient to replace water used in the recipe.
- Place foods within an ice bath and frequently stir the foods to speed the cooling process.
- Loosely cover foods so that heat and steam can escape during cooling.
- Arrange containers within a refrigeration unit so that air can flow properly around containers.
- Use special equipment like chill paddles or blast chillers to rapidly bring down food temperature.

Use an accurate thermometer to verify the food is being cooled within proper timeframes.

PROPER FOOD THAWING METHODS

1. Under refrigeration
2. In a microwave oven on "defrost"
3. Submerged under cold running water in an approved preparation sink for no longer than 2 hours
4. As part of the cooking process

INTERNAL COOKING TEMPERATURES

Use a probe thermometer to take internal cooking temperatures
